

## Central Maryland Winter Guard 2015-2016 Liability Release

### Responsibility of Participants:

As with every activity, there are risks involved in participating in color guard. If you participate with Central Maryland Winter Guard, either in the A class program or the Cadet program you accept all risks and release Central Maryland Winter Guard, sponsors or any public school facility from any liability. Before participating, you should consider the following:

- 1) Central Maryland desires to conduct its activities in a safe manner and expects your cooperation. Therefore, you must follow certain basic safety rules under the direction of Central Maryland Winter Guard:
  - a. Wear appropriate exercise clothing. (All blacks, and fitted)
  - b. Remove any jewelry that could potentially interfere with your participation.
  - c. Follow all instructions and directions give to you by the instructional staff.
  - d. When broadening your skill set, do so only under the direct supervision and consultation of an instructor.
  - e. Be respectful and mindful of the facility and equipment. Please pick up all trash. Return everything you use to the place where you found it. If the facility has a non-smoking policy, adhere to it as well.
  - f. Eat appropriately before arriving. It is your responsibility to be prepared for the physical activity involved.
- 2) Central Maryland Winter Guard instructors and support staff are volunteers who lead and conduct the events for the benefit of all. Your decision to participate and, at every point, to continue to participate is yours alone. The instructors and support staff will help you with arrangements to carry out your decisions, consistent with the resources and welfare of the group.
- 3) By registering for an event, you indicate you have the ability to complete the event safely. If you find conditions more difficult than you prepared for, you should arrange with an instructor to modify or end your participation.

Liability Release: I (the undersigned) am aware there are risks involved in marching, dancing, and spinning rifles, flags and sabers. I read and understand the above information. In consideration of my being permitted to participate in Central Maryland activities, I intending to be legally bound, waive and release any and all rights and causes of action that I may have against Central Maryland Winter Guard as well as their respective agents, representatives, and successors for any and all injuries or damages suffered by me during participation in Central Maryland Winter Guard events.
